Divorce Questionnaire

This Divorce Questionnaire is designed to help you focus your attention on the issues that may arise as a result of the breakdown of your marriage.

The following are some of the issues that will be addressed throughout this Questionnaire:

Spousal support: Spousal support is an Order that one of the spouses must pay to the other spouse, usually on a monthly basis, a specified amount of money, either for a set period of time or indefinitely.

A question you should ask yourself is: Is one spouse a high-income earner while the other spouse earns much less? If so, the higher income earner will likely have to pay spousal support to the lower income earner on a monthly basis. Depending on the length of your marriage this could be payable for an indefinite amount of time and depending upon your lifestyle, the amount could be enough to equalize the incomes of both households.

Custody and access for the children of the marriage: The word "custody" is broadly defined to include physical control over a child as well as the right to determine a child's education, healthcare, religion, and other matters concerning the child's well-being. The *Divorce Act* defines "custody" as including care, upbringing, and any other incident of custody, and there are three different types of custody: sole, joint, and shared.

Questions you should ask yourself include: Who will the children live with? Which parent will have access and when?

Child support: Child support is an amount of money paid by one parent to the other parent. Child support is payable until a child is no longer defined as a "child of the marriage" in accordance with the *Divorce Act* or a "dependent" as defined by the *Family Law Act*. The amount of child support is determined by the *Child Support Guidelines* and is based on the income of the parent paying the support and the number of children for whom support is payable.
